CPM ideologue raps State Govt for Wayanad coverup

Kailashnathan takes oath as Puducherry LG



Chief Minister Pinarayi Vijayan-led CPM in Kerala suffered a major setback on Wednesday as a widely respected party ideologue came out in the open lambasting the State Government for covering up its failures and blaming the Centre for last Tuesday's landslides and floods in Wayanad district. More than 400 lives were lost and hundreds were rendered homeless. G Shaktiadharan, known as a copybook communist and who was a senior editor of party organ Deshabhimani said in his social media post that Kerala received as disaster relief from the Centre during the current crisis is the best help which it has got from the past governments. The hour-long speech delivered by Home Minister in Parliament is an excellent proof of how the Centre has been alerting the State administration about an impending disaster days before

which Wayanad is a part. Prof Gadgil had warned of major natural disasters if the State government went ahead with quarrying, mining and construction activities. Pinarayi Vijayan, while briefing the media on 30th July, the day the district was devastated by the landslide, scoffed at the WCCE. Panel report and described the same as trash. Though a CPM(M) follower, Shaktiadharan never hesitated to speak his mind out. "Prof Gadgil had warned the State many times about the impending natural disaster. But why the CM Vijayan is reluctant to meet him and discuss with him the solution available to save Wayanad and other such regions in the State. Acting Chief Justice of Madras High Court Justice D Krishnakumar administered the oath of office and secrecy to Kailashnathan. Chief Secretary to Puducherry Kailashnathan took the oath as Puducherry LG. Police officials, opposition leader in the Assembly R Siva (DMK), A ADMK Puducherry unit Secretary A Anbalagan, officials and representatives of various organisations were among those who greeted Kailashnathan after the swearing in ceremony. Puducherry police presented the guard of honour to the new Lt Governor under Raj Nivas after the ceremony.
