## नए आयकर बिल में इससे जुड़े संशोधन हुए शामिल यूपीएस में भी एनपीएस जैसी कर छूट मिलेगी

### बदलाव

नई दिल्ली, एजेंसी। केंद्र सरकार ने राष्ट्रीय पेंशन योजना (एनपीएस) में दी जाने वाली कर छूट और जरूरी सुविधाओं को नई शुरू की गई एकीकृत पेंशन योजना (यूपीएस) में भी शामिल कर लिया है। इसके लिए नए आयकर विधेयक-2025 (संख्यांक 2) में जरूरी संशोधन शामिल किए गए हैं।

इनके तहत अब यूपीएस में भी सेवानिवृत्ति के वक्त मिलने वाली एकमुश्त राशि का 60% हिस्सा कर मुक्त होगा। ये संशोधन वित्त वर्ष 2025-26 से लागू होगा। यह बदलाव विशेष रूप से उन केंद्रीय कर्मचारियों पर लागू होगा, जो 30 सितंबर 2025 से पहले एनपीएस से यूपीएस में स्थानांतरित होने का विकल्प चुनते हैं। नए प्रावधान आयकर अधिनियम की धारा-10 (उपधारा 12ए, 12बी और 12एबी) में शामिल किए गए हैं। इसके अलावा धारा 80सीसीडी में नई उपधारा (6) भी जोड़ी गई है। कर विशेषज्ञों का कहना है कि इस कदम से

### यूपीएस में ये संशोधन शामिल किए गए

#### सेवानिवृत्ति पर कर-मुक्त निकासी

यूपीएस में शामिल कर्मचारी सेवानिवृत्ति, स्वेच्छिक सेवानिवृत्ति या सुपरनेच्यूरेशन (निर्धारित उम्र पर रिटायरमेंट) के समय अपने पेंशन कोष का 60% तक हिस्सा एकमुश्त निकाल सकते हैं। इस पर कोई आयकर नहीं देना होगा। यह व्यवस्था एनपीएस में भी लागू है।

#### जन्दी निकासी पर टैक्स

कोई कर्मचारी या नामांकित सेवानिवृत्ति या सुपरनेच्यूरेशन से पहले यूपीएस से रकम निकालता है, तो पूरी राशि उसी वित्तीय वर्ष में आय के रूप में मानी जाएगी और उस पर कर देना होगा।

#### पेंशन खरीदने के लिए राशि ट्रांसफर करना

सेवानिवृत्ति के समय अगर शेष राशि को पेंशन प्लान खरीदने के लिए 'पूल कॉर्पस' में डाला जाता है, तो कर नहीं लगेगा।

यूपीएस अपना देने वाले कर्मचारियों को वही कर छूट मिलेगी, जो एनपीएस में पहले से उपलब्ध है। इससे सेवानिवृत्ति

#### सुपरनेच्यूरेशन पर एकमुश्त राशि

सुपरनेच्यूरेशन के समय सदस्य को हर छह माह की योग्य सेवा के लिए उनके मासिक वेतन (बेसिक पे + महंगाई भत्ता) का 10% हिस्सा एकमुश्त राशि के रूप में मिलेगा। यह भी कर मुक्त होगा। यह भुगतान उसकी सुनिश्चित मासिक पेंशन को कम नहीं करेगा।

#### बाहर निकलना या ख़ाता बंद करना

अगर कोई सदस्य सेवानिवृत्ति से पहले यूपीएस खाता बंद करता है या योजना से बाहर निकलता है, तो निकाली गई पूरी राशि (ब्याज और निवेश) पर पूरा टैक्स लगेगा।

अगर कोई सदस्य पेंशन प्लान खरीदने के लिए 'पूल कॉर्पस' में डाला जाता है, तो कर नहीं लगेगा।

## हर्षिल में झील ने बढ़ाई चिंता, जम्मू में भारी बारिश से स्कूल हुए बंद

देहरादून, मुख्य संवाददाता/जम्मू, एजेंसी। उत्तरकाशी के धराली और हर्षिल में पांच अगस्त को आई आपदा के बाद बनी झील ने चिंता बढ़ा दी है। धराली के अलावा हर्षिल में आए मलबे से भागीरथी का प्रवाह प्रभावित हुआ है।

उधर, जम्मू के विभिन्न जिलों में बीते कुछ दिनों से हो रही भारी बारिश के कारण मंगलवार को अचानक बाढ़ आ गई, जिससे चार इमारतें क्षतिग्रस्त हो गईं और कुछ सड़कें बंद हो गईं। राजौरी, रियासी और पूंछ जिलाधिकारियों ने खराब मौसम के चलते सभी स्कूलों को बंद करने का निर्देश दिया है।

उत्तरकाशी के हर्षिल में करीब 1200 मीटर लंबी और 60 मीटर तक चौड़ी झील बन गई है। झील से पानी की काफी कम निकासी हो रही है।

इससे यहां जल स्तर में बढ़ रहा है। यहां भागीरथी किनारे स्थित हाईवे भी झील की चपेट में आ गया है। झील से पानी की निकासी के लिए वैज्ञानिकों के साथ ही यूजेवीएनएल और सिंघाई वोलन के 30 इंजीनियरों की टीम को मौके पर भेजा गया है। हर्षिल की झील को पंचर कर उससे पानी की व्यवस्थित निकासी के अभी तक के प्रयास सफल नहीं हो पाए हैं। यहां पांच अगस्त के सैलाब के साथ आए मिट्टी पत्थरों के साथ भारी भरकम पेड़ों ने भागीरथी के प्रवाह को रोक दिया है। झील से पानी की निकासी के लिए भागीरथी के मुहाने पर फंसे पेड़ों को हटाने का काम किया जा रहा है। इसमें एसडीआरएफ और यूजेवीएनएल की टीमों झील में फंसे पेड़ों को काटकर हटाने का काम कर रही हैं।

### समी नागरिकों का संरक्षक है सुप्रीम कोर्ट: सीजेआई

नई दिल्ली। सुप्रीम कोर्ट ने मंगलवार को खुद को देश के सभी नागरिकों का 'संरक्षक' बताते हुए कहा कि वह यह सुनिश्चित करने के लिए समुचित दिशानिर्देश जारी करेगा ताकि कानूनी पेशे की स्वतंत्रता और वकील-मुचिकल विशेषाधिकार का उल्लंघन न हो। शीर्ष अदालत ने अपराधिक मामले में मुचिकलों को सलाह देने के लिए जांच एजेंसियों द्वारा वकीलों को समन जारी करने के मुद्दे पर अपना फैसला सुरक्षित रखते हुए यह टिप्पणी की।

## अग्रिम कर का मुग़तानन होने पर 3% ब्याज लगेगा

नई दिल्ली। वित्त मंत्रालय ने नए आयकर विधेयक में अग्रिम कर की कम अवधिगी पर ब्याज वसूली संबंधी प्रावधान को लेकर मंगलवार को एक सुनवाई अधिसूचना जारी की।

इस अधिसूचना में निर्धारित तारीख तक अग्रिम कर की कम अवधिगी करने पर तीन प्रतिशत ब्याज की वसूली का प्रावधान किया गया है। इस प्रावधान को आयकर अधिनियम, 1961 के मौजूदा प्रावधानों के अनुरूप बना दिया गया है।

## ट्रंप के ऐलान से सोने की रफ़्तार थमी

### वाशिंगटन/ नई दिल्ली, एजेंसी।

अमेरिकी राष्ट्रपति डोनाल्ड ट्रंप ने ऐलान किया है कि सोने के आयात पर कोई अतिरिक्त शुल्क नहीं लगेगा। उनके इस बयान से अंतराष्ट्रीय बाजार में सोने के दाम एक फीसदी से अधिक टूट गए। भारत में भी इसकी कीमत मंगलवार को एक हजार रुपये फिसल गई।

ट्रंप का बयान ऐसे समय आया है, जब कयास लगाए जा रहे थे कि अमेरिकी सीमा शुल्क और सीमा सुरक्षा विभाग सोने की इंटों (गोल्ड बार) पर टैरिफ लगा सकता है। इस खबर से अंतरराष्ट्रीय बाजार में सोने

### बिकवाली से सोना 1,000 रुपये लुढ़का

वैश्विक बाजारों में बिकवाली के चलते मंगलवार को राष्ट्रीय राजधानी में सोने की कीमत 1,000 रुपये गिरकर 1,01,520 रुपये प्रति 10 ग्राम रही। सोमवार को 99.9 प्रतिशत शुद्धता वाला सोना 1,02,520 रुपये प्रति 10 ग्राम के भाव पर बंद हुआ था। वहीं, चांदी भी 2,000 रुपये की गिरावट के साथ 1,12,000 रुपये प्रति किलोग्राम (सभी करों सहित) के भाव पर आ गई। सोमवार को यह 1,14,000 रुपये प्रति किलोग्राम पर बंद हुई थी। विश्लेषकों का कहना है कि ट्रंप के बयान के बाद सोने की कीमतों में गिरावट आई।

स्विट्ज़रलैंड दुनिया का सबसे बड़ा सोना रिफाइनिंग केंद्र है, जहां से अन्य देशों को सोने की आपूर्ति की जाती है। शुल्क को लेकर अनिश्चितता के चलते कुछ स्विस रिफाइनरियों ने सोने की आपूर्ति रोक दी थी।

Man held for flying drone near CM's event



A man was briefly detained on Tuesday for allegedly flying a drone near Connaught Place while Chief Minister Rekha Gupta was attending an event in the area, a police source said. "The man was detained for some time and was later released after being made to understand that drone is not allowed for the time for security reasons of Independence Day," said the source.

The source said that while Gupta was attending a programme, police deployed for security noticed a drone hovering in the vicinity and accosted its operator. It turned out that the detained man was part of the chief minister's media team. Delhi Police Commissioner S B Singh had on August 2 ordered a ban on sub-conventional aerial platforms across the national capital till August 16 because of Independence Day.

The ban covers paragliders, para-motors, hang-gliders, UAVs (Unmanned Aerial Vehicles), UAVs (Unmanned Aircraft Systems), micro-light aircraft, hot air balloons, small-sized powered aircraft, quadcopters and remotely piloted aircraft.

Delhi: Liquor shops shut on Independence Day, Anamshanti

Delhi will observe back-to-back dry days this week with all liquor shops shut on Independence Day and Anamshanti. This directive comes from the Delhi government's excise department under Rule 52 of the Delhi Excise Rules, 2010. According to the excise department's order, all retail liquor shops, bars, restaurants, hotels, and clubs must shut down on Independence Day. Additionally, the same restrictions will apply on October 2, the birth anniversary of Mahatma Gandhi. These dry days are observed annually to mark important national and religious occasions.

The order clarified that the dry day restrictions will not affect room service of alcohol

in hotels that hold 1-15/1-15F licences. These licences are granted to star-classified hotels approved by the tourism department of the Government of India.

Such hotels are permitted to serve alcohol to their guests through room service, reflecting a balance between tradition and hospitality services. The excise department emphasised that this exemption is strictly limited to these licensed hotels and does not extend to other establishments.

Rule 52 of the Delhi Excise Rules, 2010, mandates the closure of liquor outlets on specified dry days to promote public order and respect significant cultural and national events. These regulations have been enforced by Delhi police and excise officials to ensure compliance.

Delhi Assembly premises to be open for public

Delhi Assembly premises will be open for people on August 14 and August 15 on the occasion of Independence Day, according to an official statement issued on Tuesday. A Border Security Force (BSF) band will play patriotic tunes, and a cultural performance will also be held to mark the occasion. It said.

People will be allowed to visit the Vidhan Sabha building between 5 pm and 8 pm on August 14 and August 15, and will get a tour of historical sites on the premises, the statement said.

No registration will be required for the visit on both days, and proper identity cards have to be shown for entering the Assembly premises.

DTC electric buses to go for body wrap commercial advertisements

The electric buses of Delhi Transport Corporation (DTC) will soon be seen criss-crossing the city roads wearing colourful, body wrap commercial advertisements. The long-pending proposal of the DTC for extra revenue generation was stalled for years over road safety concerns raised by the Traffic police. "Now the DTC will provide 840 of its electric buses for whole body wraps to a concessionaire selected through

bidding for which tender has been floated," said a senior Transport department officer. The DTC has also laid down rules to ensure no indecent or objectionable advertisements are displayed on the buses, he said.

As a part of an overall exercise to enhance revenues for DTC, it intends to grant permission to bus body wraps. The total number of 842 air-conditioned e-buses from nine depots are available for display of advertisement on the exterior. The number of buses available for whole body wraps will increase in the coming



days, the officers said. Importantly, the proposal for the permission of advertisements on the right side of the buses is under consideration, said the tender document.

The DTC may consider granting permission to the successful bidder to advertise on the right side by charging an additional fee for the extra space, it said.

In future, if the fleet strength is increased, the concessionaire will have the right of refusal to refuse advertisement on new buses, and it will be passed on to the next bidders, said the document.

The concessionaire will have to ensure that the advertisements are not "indecent, obscene and otherwise offensive" to good taste or against public sentiments or in contravention of the applicable laws, including MCD Bye Laws on advertisements, it said.

As such, negative advertisement contents like nudity, drugs, alcohol, cigarettes, tobacco, those propagating caste, community, ethnic differences, sex, or overt racism, among others, as well as advertisements banned by the Advertisement Council of India or by law, will not be permitted, it added.
