Bosnia beat Ivory Coast

St. Louis Bosnia-Herzegovina made its second appearance in St. Louis in six months. This time, it gave its large, enthusiastic local fan base plenty to cheer about.

Eduin Dzeko scored both goals in a 2-1 victory over Ivory Coast on Friday night in the run-up to the country's first World Cup appearance.

"We knew they were going to be a powerful team with good pace and they showed that," goalkeeper Asmir Begovic said.

"It was a good test for us to play against a good team and we enjoyed it."

They estimated more than 30,000 Bosnians relocated to St. Louis from the former war-torn Yugoslavia, and the games have provided an opportunity to display national pride.

Argentina shut out the national team 2-0 in November across downtown at Busch Stadium.

Long-time Ivory Coast starter Dražđa scored on a free kick in the 91st minute. The 36-year-old Dražđa did not start but had another good scoring chance after entering in the second half.
