## Route diversions announced ahead of PM's visit to Noida airport

The Gautam Buddha Nagar Traffic Police has issued a detailed advisory ahead of Prime Minister Narendra Modi's visit to Noida International Airport on March 28. Noida Police officials have advised commuters to follow designated routes and avoid unnecessary travel near the venue to ensure the smooth conduct of the high-profile event.

According to Noida Police officials, the entry routes and parking zones have been marked. Vehicles from Meerut and Ghaziabad will be

routed via the Eastern Peripheral Expressway, while those from Mathura and Aligarh will take the Yamuna Expressway. Separate parking zones have been earmarked, including P-07 for Meerut and P-06 for Ghaziabad.

Commercial vehicles will be diverted, and goods vehicles will be restricted on the Noida-Greater Noida Expressway and surrounding roads from 7 am to 11 pm.

Emergency vehicles such as ambulances and fire services will have uninterrupted passage. Parking Arrangements: 15 parking facilities have been arranged for 14,700 heavy and medium

vehicles and 5,000 two-wheelers.

Traffic coming from Mathura and Aligarh via the Yamuna Expressway will exit at Jewar Cut and enter through Sabautia Underpass and Kishorpur Gate, with parking allocated in zones P-05, P-09 and P-11.

Vehicles from Hapur, Bulandshahr and nearby areas will be diverted along the Jewar-Khurja road and enter through Parohi Gate, with parking arranged in zones P-13 and P-14.

Dignitaries will access the venue through the dedicated Yamuna Expressway interchange and park in zones P-



01, P-02 and P-03, while media personnel will enter via Kishorpur Gate and park in P-08. Police, administrative staff and government employees on duty will also use the Kishorpur Gate, with parking designated at P-10, while official buses will be routed via Dayanantpur and parked in P-15.

Commuters from Noida and Greater Noida using the Noida-Greater Noida Expressway will be diverted through specified roundabouts and service roads before entering via a temporary gate near Ranehra Police Post, with parking mainly at P-07.

Vehicles from Greater Noida West and surrounding areas will be routed through Pari Chowk, while those from Dankaur and nearby regions will follow service roads and canal routes to designated entry points. Two-wheelers and light motor vehicles will be allowed entry through Kishorpur Gate with parking at P-04, while vehicles from Jewar town will use the same gate and park in P-12.

Commercial vehicles on the Jewar-Tappal route will be diverted towards Tappal, while those from Khurja heading to Jewar will be stopped at Khurja itself and redirected.

## Government working to improve drinking water supply, sewer connectivity: Verma

Delhi PWD Minister Parvesh Sahib Singh Verma on Friday said the State Government is working on a war footing to improve drinking water supply, sewer connectivity and cleaning the Yamuna River.



Giving a detailed presentation about steps taken in the Delhi assembly, he also highlighted the findings of the Comptroller and Auditor General of India (CAG) report, exposing years of systemic failures in water management, sewer infrastructure, and Yamuna cleaning.

He also noted that during the assembly session, several MLAs raised concerns about water supply, sewer issues, and local infrastructure challenges in their constituencies, directly reflecting the grievances of citizens. However, the minister strongly criticised the absence of the opposition during such a critical discussion.

Delhi currently requires approximately 1200 MGD of water, while the supply stands at around 1000 MGD, creating a persistent gap. The Minister pointed out that, beyond supply constraints, poor management and massive transmission losses have worsened the crisis.

To improve water availability, an additional 36 MGD capacity is being added, major projects like Chandrawal and Wazirabad revived, and long-pending interstate water coordination strengthened.

As regards Yamuna cleaning, he said key steps include construction and upgradation of 35 STPs with global standards, expansion of treatment capacity to 1500 MGD for future needs, in-situ treatment of major drains including Najafgarh drain, and strict monitoring of sewage discharge and quality. He also announced that within 2 to 2.5 years, Delhi will have more treatment capacity than sewage generation, ensuring long-term sustainability.

## Phansi-ghar row: Assembly issues warning to AAP leaders

The Delhi Assembly on Friday issued a warning to AAP leaders, including former chief minister Arvind Kejriwal, regarding the 'Phansi-ghar' issue, based on a report from its Privileges Committee.

Speaker Vijender Gupta spoke about the "manufactured narrative" of a 'Phansi-ghar' within the assembly premises, stating that associating the famed building with an execution chamber is a disservice to its true history.

"The House is deliberating on this matter with absolute

justice. The contempt has been proven. While no court in India can grant relief in matters of legislative privilege, we are proceeding based on the dignity of this institution," a statement said.

A Privileges Committee report, which was tabled in the assembly on March 23, was discussed in the House. Following the discussion, the House addressed a motion proposed by BJP MLA Jintendra Mahajan.

Mahajan recommended issuing a warning to Kejriwal and other AAP leaders for showing contempt by failing to appear before the committee. The motion was second-



ed by ruling party MLA Raj Kumar Bhatia, and the House ultimately passed it via a voice vote.

The Phansi-ghar was inaugurated in the assembly by Kejriwal, in the presence of

then deputy chief minister Manish Sisodia, speaker Ram Niwas Goel and deputy speaker Rakhi Birla, on August 9, 2022.

The Speaker criticised the neglect of Delhi's rural

martyrs while "fake stories" of execution rooms were being circulated. After the BJP took power in Delhi in February of the previous year, the issue was raised in the assembly, with Speaker Gupta labelling it a "tiffin room" rather than a gallows where freedom fighters were hanged.

"A third report from the committee will specifically address the lies spread regarding the Phansi-ghar. The assembly secretariat and the Committee of Privileges would ensure that the sanctity of the House is never compromised by misinformation or the defiance of officials," the statement added.

## Concerns raised by MLAs to be resolved by officers: Speaker

Delhi Assembly Speaker Vijender Gupta assured members on Friday that the issues they raised through special mentions in the House would be properly addressed and resolved by the concerned officers.

During the budget session, several MLAs from the ruling BJP expressed frustration that matters they raised through special mentions were either unanswered or

only partially addressed, often without offering any solutions.

Jangpura MLA Tarvinder Singh Marwah pointed out the absence of officers in the gallery, lamenting that it indicated a lack of seriousness towards the issues raised in the House.

Raj Kumar Bhatia, MLA from Adarsh Nagar, highlighted that replies from various departments often failed to provide solutions to the issues raised by legisla-



"Sometimes the response states that the matter is not related to our department, much like RTI replies. If that is the case, who will address these issues?" he questioned.

Speaker Gupta responded that clear instructions had been given to the officers. He encouraged members who were dissatisfied with the replies they received to inform him.

"The procedure is that such replies are sent to the Committee on Questions and References, which summons officers and the MLA concerned for resolution of the issue," he said.

Timarpur MLA Surya Prakash Khatri claimed that replies were frequently not provid-

ed, often due to trivial technical reasons.

The speaker suggested that MLAs directly present the issues from their constituencies, rather than framing them in question form, to facilitate timely resolutions.

He mentioned that the assembly would engage in discussions with officers regarding the legislators' objections before handing over the matters to the Questions and References Committee.
