Subject- Request to holders of physical securities for mandatory furnishing PAN, KYC details and Nomination

This is to inform you that Securities & Exchange Board of India (SEBI) vide its circular no. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/655 dated November 03, 2021 read with circular no. SEBI/HO/MIRSD/MIRSD_RTAMB/P/CIR/2021/687 dated December 14, 2021 has notified simplified norms for processing investor's service request by RTA and made mandatory for the shareholders holding physical shares in the Company to furnish PAN, Contact, Bank account, Nomination details and Banker's attestation of the signature with Company's RTA latest by March 31, 2023.

IMPORTANT: In the event of non-receipt of the above details, concerned shares shall be frozen by RTA w.e.f. April 01, 2023.

In this connection, SEBI has specified the following forms for the holders of physical securities for raising requests relating to registration or changes/ updation of PAN, KYC details, nomination and confirmation of signatures of security holder by the banker-

- Form ISR- 1 - Request for registering PAN, KYC details or changes / updation thereof (Self attested copy of PAN card & Address proof (Preferably Aadhar) of the shareholder/s)
- Form ISR- 2 - Confirmation of Signature of securities holder and Bank details from your Banker along with cancelled cheque leaf with printed name (If name is not printed on the cheque , please provide legible copy of Bank passbook/Bank statement with Bank's stamp)
- Form SH- 13 - Nomination form duly filled in and signed form or duly signed **Form ISR-3** in case Nomination not required.
- Form ISR- 3 - Declaration for opting-out/ Cancellation of Nomination
- Form SH- 14 - Change in Nomination
- Valid Mobile No & Email address to be provided as per enclosed format.

Physical shareholders shall also note that the folios in which PAN is not linked to AADHAAR as on March 31, 2022 or any other date as may be specified by the Central Board of Direct Taxes will also be frozen by the Company's RTA.

Further, as per the directions of SEBI, Company's RTA shall not process any service requests from any holder of physical security w.e.f. January 01, 2022 unless their KYC, Nomination and PAN details are updated.

All the shareholders holding physical securities of the Company are requested to furnish/ update PAN, KYC and Nomination details at the earliest to the RTA as per address/ details given below, if not done earlier, with the Company's RTA.

Kind Attention: SEBI has issued SEBI (Listing Obligations and Disclosure Requirements) 4TH Amendment Regulations, 2018 and amended the provision relating to transfer of listed Securities. The amendment mandates that a request for transfer of securities shall not be processed unless the securities are held by the shareholders in dematerialized form with the Depository. Further Share in Demat form will improve ease & convenience in the transfer of securities. The aforesaid amendment is already effective from April 01, 2021.



Note

- It is mandatory for holders of physical securities in listed company to furnish PAN, full KYC details (address proof, bank details, e-mail address, mobile number) and Nomination (for all the eligible folios).
- Upon receipt or up-dation of bank details, the RTA automatically, pay electronically, all the moneys of / payments to the holder that were previous unclaimed / unsuccessful.
- RTA shall update the folio with PAN, KYC details and Nominee, within seven working days of its receipt. However, cancellation of nomination, shall take effect from the date on which this intimation is received by the company / RTA.
- RTA shall not insist on Affidavits or Attestation / Notarization or indemnity for registering / up-dating / changing PAN, KYC details and Nomination.
